

PERFORCE® P4 CORE AND P4 ONE SUPPLEMENTAL TERMS

These Perforce® P4 Supplemental Terms (“**P4 Terms**”) supplement the Master Terms and Conditions between Perforce and Customer. Capitalized terms not defined herein shall have the meanings set forth in the Master Terms and Conditions. In the event of any conflict between these P4 Terms and the Master Terms and Conditions, these P4 Terms shall control with respect to the Perforce P4 Core offering (the “**P4 Core Offering**”) and the P4 One offering (the “**P4 One Offering**”) only.

1. ADDITIONAL DEFINITIONS

The following definitions apply to these P4 Terms:

“**Authorized Users**” means any individual who is an employee, temporary employee, customer, contractor, or third-party agent who has been authorized by the Customer to log into and access Customer’s instance of the P4 Core Offering. For the avoidance of doubt, an Authorized User will include (i) a separate email address or account that receives electronic messages or data within the Customer’s email system or network, and (ii) any non-human operated device will be counted as an Authorized User under the Master Terms and Conditions, if such devices can access the P4 Core Offering.

“**Background Job**” is a software program that uses, or accesses, the P4 Core Offering’s server, either by means of Perforce’s client programs or the Perforce client API, to perform automated tasks.

“**Software**” means the machine-readable object code of Perforce’s P4 One computer software program, and the then-current printed and digital user manual(s), instructions, on-line help files, and technical documentation for such computer software program(s) made available by Perforce (collectively, the “**Documentation**”), and any modified or updated versions of any of the foregoing made available to Customer by Perforce.

2. P4 CORE LICENSE TYPES

All P4 Core Offering licensed under the terms of the Master Terms and Conditions will be licensed under one of the following licensing subtypes.

- 2.1. **Named License.** In the case of named licenses for the P4 Core Offering (each a “**Named License**”), each Authorized User of Customer will be assigned a unique and fixed user account to consume one license to use the P4 Core Offering licensed under the Agreement on a single server, or on multiple servers, regardless of whether such individual is actively/ using the P4 Core Offering at any given time. The Authorized User who is assigned a Named License will have full access to the functionality of the P4 Core Offering.
- 2.2. **Bot User License.** In the case of a bot user license for the P4 Core Offering (a “**Bot User License**”), the Authorized User has limited access to the functionality of the P4 Core Offering. The Authorized User assigned a Bot User License is only permitted to schedule and run “Background Jobs” in connection with the use of the P4 Core Offering and does not have access to any Graphical User Interfaces (“**GUI**”) within the P4 Core Offering. A single Bot User License may be used to run multiple Background Jobs, but the Customer must acquire the number of Bot User Licenses equal to the number of unique Background users it requires (e.g., to provide for traceability and security). Any use of the Bot User License for any other purpose than as set forth in this Section 2.2 will be a breach of the Agreement.
- 2.3. **Git Only License.** In the case of a Git only user license (a “**Git Only License**”), the Authorized User has limited access to the functionality of the P4 Core Offering. The Authorized User assigned a Git Only License is restricted to interactions within the P4 Core Offering to contents that are stored in depots of the type, “graph,” “spec,” and “upload,” and the Authorized User holding a Git Only License is not permitted to access any other functionality of the P4 Core Offering. Any use of the Git Only License for any other purpose than as set forth in this Section 2.3 will be a breach of the Agreement.
- 2.4. **No Shared Use of Any of the License Types.** A separate license is required for each Authorized User and may not be shared. Any of the licenses referenced in Sections 2.1 - 2.4 above that are assigned to an Authorized User to access the P4 Core Offering may not be reassigned other than for the permanent transfer of such license to another Authorized User if the current Authorized User is no longer authorized to have access to the P4 Core Offering.

3. P4 ONE LICENSE TYPES

All Software licensed under the terms of the Master Terms and Conditions will be licensed under one of the following licensing subtypes.

- 3.1. **Non-Commercial Use Restriction.** The license granted for P4 One is limited to Customer's own direct, non-commercial, and internal business purposes, and subject to any limitation on use specified in this Agreement.
- 3.2. **Time-Based License.** The P4 One license is a time-based license that will expire according to the terms specified in the Order Form.
