

## PERFORCE® P4 PLAN SUPPLEMENTAL TERMS

These Perforce® P4 Plan Supplemental Terms (“**P4 Plan Terms**”) supplement the Master Terms and Conditions between Perforce and Customer. Capitalized terms not defined herein shall have the meanings set forth in the Master Terms and Conditions. In the event of any conflict between these P4 Plan Terms and the Master Terms and Conditions, these P4 Plan Terms shall control with respect to the Perforce P4 Plan offering only (the “**P4 Plan Offering**”).

### 1. ADDITIONAL DEFINITIONS

The following definitions apply to these P4 Plan Terms:

“**Authorized Users**” shall mean an employee or third party agent of Customer who is assigned a unique and fixed user account to consume one license to use the P4 Plan Offering licensed under this License Agreement on a single server, or on multiple servers, regardless of whether such individual is actively using the P4 Plan Offering at any given time. A non-human operated device will be counted as an Authorized User in addition to all individuals authorized to use the P4 Plan Offering licensed under the Agreement if such devices can access such P4 Plan Offering.

“**SDK**” means the software development kit that contains plugins, tools, and application programming interfaces that interact with the P4 Plan Offering licensed under this Agreement. The SDK also includes the programming application, programming interface, example code, associated media, and the Documentation for which Customer has paid the applicable license fees and been granted a corresponding license to access by Perforce subject to the terms and conditions contained in this License Agreement.

### 2. USER LICENSE TYPE

All P4 Plan Offerings licensed under the terms of the Agreement will be licensed under one of the following licensing subtypes.

- 2.1. **Regular Users.** In the case of regular named licenses for the P4 Plan Offering (each, a “**Regular Named License**”), each Authorized User of Customer (each, a “**Regular User**”) who is assigned a Regular Named License will have full access to the functionality of the P4 Plan Offering. A separate license is required for each Regular User, and the Regular Named License may not be used or accessed by any individual or automated process other than the assigned Regular User. Any of the Regular Named Licenses that are assigned to a Regular User to access the P4 Plan Offering may not be reassigned other than for the permanent transfer of such Regular Named License to another Regular User if the current Regular User is no longer authorized to have access to the P4 Plan Offering.
- 2.2. **Special Users.** In the case of special named licenses for the P4 Plan Offering (each, a “**Special Named License**”), each Authorized User of Customer who is assigned a Special Named License (each, a “**Special User**”) will have limited access to the functionality of the P4 Plan Offering. For each Regular Named License granted to Customer, Customer will receive ten (10) Special Named Licenses. Customer may assign the number of Special Named Licenses granted under this Agreement among any of the three (3) categories of Special Users; provided, however, that, if Customer wants to assign the same named Special User to more than one (1) of the Special User types, each Special Named License that the Special User is assigned to will count against the total number of Special Named Licenses granted to Customer.
- 2.3. **Types of Special Users**
  - 2.3.1. **QA Users.** In the case of quality assurance Special Named Licenses (each, a “**QA User License**”), the Special User is only permitted to access the quality assurance functionality of the P4 Plan Offering (each, a “**QA User**”), and the QA User is not permitted to access any other functionality of the P4 Plan Offering. Any use of the QA User Licenses by Customer for any other purpose than as set forth in this Section 2.3.1 will be a material breach of this License Agreement.

- 2.3.2. SDK Users. In the case of SDK Special Named Licenses (each, a “**SDK User License**”), and provided that Customer has been granted a license to the SDK, the Special User is permitted to access the SDK functionality of the P4 Plan Offering solely for the purposes of integration, customization, or authentication to the P4 Plan Offering through the SDK functionality of the P4 Plan Offering (each, a “**SDK User**”), and the SDK User is not permitted to access any other functionality of the P4 Plan Offering or use or access the SDK to bypass any other licensing of Perforce Software. Any use of the SDK User Licenses by Customer for any other purpose than as set forth in this Section 2.3.2 will be a material breach of this License Agreement.
- 2.3.3. Placeholder Users. In the case of placeholder Special Named Licenses (each, a “**Placeholder User License**”), the Special User is granted a Placeholder User License solely for resource planning purposes (each, a “**Placeholder User**”). The Placeholder User is not permitted to log in to the P4 Plan Offering or to access any of the functionality of the P4 Plan Offering. Any use of the Placeholder User Licenses by Customer for any other purpose than as set forth in this Section 2.3.3 will be a material breach of this License Agreement. A Placeholder User may be converted to a Regular User so long as the Customer pays the license fee.
- 2.3.4. Any of the Special Named Licenses referenced in this Section 2.3 that are assigned to a Special User to access the P4 Plan Offering may not be reassigned other than for the permanent transfer of such Special Named License to another Special User if the current Special User is no longer authorized to have access to the specific functionality of the P4 Plan Offering set forth in Sections 2.3.1-2.3.3 above.
